





- कार्यान्वित योजनाओं में स्थल/ लाभुक का चयन में दोहरीकरण न करते हुए, जहाँ विगत तीन वर्षों से गाँव/ पंचायत का चयन नहीं किया गया है, वहाँ पारदर्शिता के साथ लाभुकों का चयन करना सुनिश्चित करेंगे।
- जिन गतिविधियों हेतु लाभुकों का चयन किया जाएगा, उस गतिविधि को करने हेतु लाभुकों के पास पर्याप्त संसाधन एवं रूचि होनी चाहिए।
- फसल प्रत्यक्षण हेतु ऐसे स्थलों का चुनाव करें, जहाँ सिंचाई की सुविधा सुनिश्चित हो।
- फसल प्रत्यक्षण हेतु बीज वितरण Block Chain Technology के माध्यम से करना सुनिश्चित करें।
- कृषि यंत्र वितरण हेतु लाभुकों का चयन करते समय यह ध्यान रखा जाए कि लाभुक के पास कृषि यंत्र के अनुसार आवश्यक रकवा एवं अपने प्रक्षेत्र पर यंत्र संचालन हेतु पर्याप्त संसाधन होने चाहिए, ताकि किसान कृषि यंत्रों को सही ढंग से प्रयोग में ला सके।




